TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is made as of August 6, 2014, by Madison Capital Funding LLC, as administrative agent ("Grantee").

W I T N E S S E T H:

WHEREAS, Grantee and CompPartners, Inc., a California corporation ("Grantor") are parties to that certain Trademark Security Agreement dated as of December 20, 2012 (the "Agreement"; capitalized terms which are not defined herein have the meaning given to such terms in the Agreement), pursuant to which Grantor granted a security interest to Grantee in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor and its affiliates to Grantee;

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on December 20, 2012 at Reel 4926 Frame 0472;

WHEREAS, Grantor has requested that Grantee release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor; and

WHEREAS, Grantee has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in and lien on all of Grantor's right, title and interest in the following (collectively, the "Trademark Collateral"):

(i) each of its Trademarks and Trademark Licenses to which it is a party, including, without limitation, those listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of each such Trademark or any Trademark licensed under any Trademark License, or (b) injury to the goodwill associated with each such Trademark or any Trademark licensed under any Trademark License.

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest (if any) in and to the Trademark Collateral.
