TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks (this "Release") dated as of July 28, 2014, is made by Amalgamated Bank (the "Lender").

RECITALS:

WHISTLEPIG, LLC (the "Borrower") and Lender entered into a certain Trademark Assignment of Security Agreement (the "Agreement"), dated as of March 28, 2013 and recorded with the U.S. Patent & Trademark Office on July 12, 2013 at Reel 5068, Frame 0632, pursuant to which the Borrower granted to Lender a lien on and security interest in the Marks (as such term is defined in the Agreement).

The Borrower has requested the Lender to release, and the Lender has agreed to release, its lien on the Marks, the goodwill of the business symbolized by the Marks and the registrations and applications therefore (the "Security Interest"), pursuant to the Agreement.

AGREEMENT:

Lender hereby terminates the Agreement and releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by the Borrower pursuant to the Agreement in all Security Interest, including, without limitation, the Marks identified on Schedule A annexed and all liens, charges or other encumbrances in favor of the Lender in the Security Interest shall hereby terminate and revert to the Borrower and all right, title and interest of Lender in the Security Interest will hereby cease, terminate and become void.
