TRADEMARK ASSIGNMENT

WHEREAS, "LEGATRIN" is registered in the Canada Intellectual Property Office in connection with analgesic preparations for the relief of leg cramps, and having been designated Registration Number TMA334,280;

WHEREAS, Assignee desires to acquire said Marks and registrations therefor;

WHEREAS, Assignor desires to convey, transfer, assign and deliver to Assignee, and Assignee desires to accept from Assignor, the Marks and the registrations therefor;

NOW, THEREFORE, for valuable consideration the receipt of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:


