RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

WHEREAS, O'REILLY & ASSOCIATES, INC., a Massachusetts corporation (the "Original Assignor"), granted a security interest to WELLS FARGO BANK, NATIONAL ASSOCIATION (the "Bank"), in and lien upon certain trademarks as set forth in that certain (i) Trademark Collateral Security and Pledge Agreement effective as of April 15, 2002 by the Original Assignor in favor of the Bank (the "Trademark Memorandum"), which was recorded in the United States Patent and Trademark Office on July 11, 2003 at Reel 002682, Frame 0452 and (ii) that certain First Amendment to Trademark Collateral Security and Pledge Agreement dated December 17, 2003 by Original Assignor, O'Reilly Media, Inc., a Delaware corporation (successor by merger with Original Assignor) in favor of the Bank (the "First Amendment"), which was recorded in the United States Patent and Trademark Office on July 15, 2004 at Reel 002893, Frame 0460;

WHEREAS, Assignor has requested that the Bank release and reassign to Assignor its respective interests in the trademarks identified in **Schedule A** hereto and made a part hereof.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Bank hereby:

1. releases and reassigns to Assignor any and all liens, security interests, right, title and interest of the Bank pursuant to the Trademark Memorandum and the First Amendment in the trademarks identified in **Schedule A** and/or any goodwill associated with any of the trademarks identified in **Schedule A**, without recourse or representation or warranty, express or implied of any kind; and
2. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
