

Online Resources Corporation, a corporation incorporated on February 22, 1989 (the "Corporation"), pursuant to the provisions of the General Corporation Law of the State of Delaware;

**DOES HEREBY CERTIFY:**

**FIRST:** The Corporation owns 100% of the capital stock of Princeton eCom Corporation, a corporation incorporated on January 25, 1984, pursuant to the provisions of the General Corporation Law of the State of Delaware, and that the Corporation, by resolutions of its Board of Directors duly adopted by written consent in lieu of a meeting on December 16, 2013, determined to merge into itself Princeton eCom Corporation, which resolutions are in the following words to wit:

WHEREAS, the Corporation lawfully owns 100% of the outstanding capital stock of Princeton eCom Corporation, a corporation organized and existing under the laws of Delaware; and

WHEREAS, the Corporation desires to merge into itself Princeton eCom Corporation and to be possessed of all the estate, property, rights, privileges, and franchises of said corporation.

NOW, THEREFORE, BE IT:

RESOLVED, that the Corporation merges into itself Princeton eCom Corporation and assumes all of its liabilities and obligations.

RESOLVED FURTHER, that the officers of the Corporation are hereby authorized and directed to make and execute a Certificate of Ownership setting forth a copy of the resolution to merge Princeton eCom Corporation and assume its liabilities and obligations, and the date of adoption thereof, and to file the same, as appropriate, in the office of the Secretary of State of Delaware.

RESOLVED FURTHER, that the officers of the Corporation are hereby authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in any way necessary or proper to effect said merger.

RESOLVED FURTHER, that the merger shall become effective at 11:59 p.m. Central Time on December 31, 2013.


**SECOND:** That anything herein or elsewhere to the contrary notwithstanding, this merger may
