RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of August 7, 2014 (this "Release") is made by JPMorgan Chase Bank, N.A., (the "Lender") under that certain Trademark Security Agreement, dated as of August 17, 2011 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among Gabriel Performance Products, LLC, an Ohio limited liability company and Gabriel Holdings, LLC, a Delaware limited liability company (individually, a "Pledgor", and, collectively, the "Pledgors") and the Lender.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on August 31, 2011 at reel 4614, frame 0817, each Pledgor granted to the Lender a continuing security interest in all of Pledgor's right, title and interest in, to and under its owned or thereafter acquired Trademarks (as defined in the Trademark Security Agreement), including those trademark and service mark registrations and applications set forth on Schedule 1 attached hereto; and

WHEREAS, each Pledgor has requested and Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademarks, (b) release its security interest in the Trademarks, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Lender in the Trademarks.
