## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is dated as of August 12, 2014 by CERBERUS BUSINESS FINANCE, LLC, in its capacity as agent for the Lenders (together with any successors and assigns thereto in such capacity, the "Agent"), in favor of THE SPECIALIZED PACKAGING GROUP, INC., a Delaware corporation, SPECIALIZED PACKAGING RADISSON LLC, a New York limited liability company, MANCHESTER INDUSTRIES INC. OF VIRGINIA, a Virginia corporation, PAPERWORKS INDUSTRIES, INC., a Delaware corporation, QCSI, INC. a Michigan corporation, ROS-MAR LITHO INC., a corporation organized under the laws of Canada, SPECIALIZED PACKAGING (LONDON) LIMITED, a corporation organized under the laws of the province of Nova Scotia, Canada and GIBRALTAR PACKAGING, INC. a Delaware corporation (each a "Grantor" and collectively, the "Grantors"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement (as defined below).

**WHEREAS**, pursuant to that Credit Agreement, dated as of July 21, 2011 (as it may be amended, restated, supplemented or otherwise modified from time to time, including all exhibits and schedules thereto the "Credit Agreement") among the Grantors, certain of their affiliates, the lenders from time to time party thereto (the "Lenders"), and Agent pursuant to which the Grantors executed and delivered to the Agent that certain Trademark Security Agreement, dated as of July 21, 2011 (as it may be amended, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), for recordation with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 28, 2011 at Reel 004592, Frame 0364;

**WHEREAS**, pursuant to the terms and conditions of the Credit Agreement and the Trademark Security Agreement, each Grantor granted to the Agent, for the benefit of the Lenders, a continuing first priority security interest in all of such security interest (the "Security Interest") in Grantors' right, title and interest in, to and under the following, whether then existing or thereafter created or acquired (collectively, the "Trademark Collateral"):

(a) all of such Grantor's trademarks, trademark applications (but excluding "intent to use" trademark applications, until such time as a statement of use had been filed therefore), service marks, trade names and associated goodwill (collectively, "Trademarks"), and licenses for any of the foregoing ("Licenses"), including those U.S. trademarks and U.S. trademark applications referred to on Schedule I hereto; and

(b) all proceeds of the foregoing, including any claim by such Grantor against third parties for past, present or future infringement or dilution of any Trademark or any Trademark licensed under any License.

**WHEREAS**, the Agent acknowledges the payment and performance of all the Obligations, and thus desires to terminate and release the Security Interest in the Trademark Collateral.


