## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of May 8, 2013, by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as Collateral Agent under the Security Agreement referenced below (in such capacity, "Agent"), in favor of Resolute FP US Inc. (f/k/a Bowater Incorporated) ("RFP US") and Resolute Forest Products Inc. (f/k/a AbitibiBowater Inc.) ("Resolute" and, together with RFP US, the "Grantors").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of December 9, 2010 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") and recorded with the U.S. Patent and Trademark Office on Reel/Frame No. 4761/0947, Grantors granted to the Agent a continuing security interest in and lien upon certain trademarks and trademark applications, including without limitation the trademarks and trademark applications set forth on Schedule 1 attached hereto (collectively, the "Trademarks");

WHEREAS, Grantors have requested that the Agent execute and deliver this release for recordation with the U.S. Patent and Trademark Office to release any lien on the Trademarks in favor of the Agent;


NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent and Grantors hereby agree as follows:

1. Release of Security Interest. The Agent hereby terminates and releases its security interests in and liens upon each of the Trademarks, and the Agent hereby assigns and transfers to the applicable Grantor, without any representation, warranty or recourse whatsoever, the Agent's entire right, title and interest in and to each of the Trademarks, effective as of the date set forth above.
2. Recordation. The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.
3. Further Instruments. At each Grantor's expense, Agent hereby agrees to execute such further instruments and documents and perform such further acts as any Grantor may deem reasonably necessary to convey to such Grantor the rights herein conveyed, without representation, warranty or recourse.
