## TRADEMARK ASSIGNMENT AGREEMENT

VISI hereby authorizes OneNeck to record ownership of the Trademark directly in OneNeck's own name in any jurisdiction, municipality, or agency, in which recordation is required.

VISI will from time-to-time after the Effective Date, upon request of OneNeck, execute, acknowledge, and deliver all such further deeds, assignments, transfers, conveyances, powers of attorney and assurances, and take such further action as may be required to carry out the intent of this Assignment, and to transfer and vest title to any trademark being transferred hereunder, and to protect the right, title, and interest in and enjoyment of the Trademark assigned hereunder.
