**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of August 14, 2014 (this "Release"), is made by PNC Bank National Association, as successor to National City Bank (the "Collateral Agent"), in favor of Hoffmaster Group, Inc. (the "Debtor") as follows:

WITNESSETH

WHEREAS, pursuant to the Trademark Security Agreement, dated January 22, 2009 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on January 23, 2009 at Reel/Frame No. 3922/0945, the Debtor granted the Collateral Agent a security interest in certain collateral pledged by the Debtor described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Debtor has paid all of its outstanding indebtedness to the Collateral Agent; and

WHEREAS, the Debtor has requested that the Collateral Agent release its security interest in all right, title and interest of the Collateral Agent in and to the Trademark Collateral.


NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty and at the Debtor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and right, title and interest of the Collateral Agent in the Trademark Collateral shall hereby terminate, cease and become void.
