## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 25, 2014 ("Release"), is made by Bank of America, N.A., as Administrative Agent ("Administrative Agent"), in favor of Triple Canopy, Inc., an Illinois corporation ("Grantor").

**WHEREAS**, pursuant to that certain Amended and Restated Security Agreement dated as of October 20, 2010 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantor, Administrative Agent, and others party thereto the Amended and Restated Trademark Security Agreement dated as of August 4, 2011 ("A&R Trademark Security Agreement") by and among the Grantor and Administrative Agent, Grantor granted to the Administrative Agent, for its benefit and the benefit of the each Secured Party, a security interest in Grantor's Trademark Collateral; and

**WHEREAS**, the A&R Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on August 25, 2011 at Reel 4611 Frame 0475.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of itself and each Secured Party, and Grantor agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or A&R Trademark Security Agreement.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of itself and each Secured Party, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under the Patent Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**IN WITNESS WHEREOF**, the Administrative Agent, on behalf of itself and each Secured Party, has caused this Termination and Release of Security Interest in Patents to be duly executed as of the date first set forth above.
