**TRADEMARK RELEASE**

TRADEMARK RELEASE, effective as of this 14 day of August, 2014, given by Deutsche Bank Trust Company Americas, as Collateral Agent, (the "Collateral Agent") with principal offices at 60 Wall Street, New York, New York 10005, to BWAY Corporation, a Delaware corporation ("BWAY"), Central Can Company, Inc., a Delaware corporation ("Central"), and North America Packaging Corporation, a Delaware corporation ("NAPC" and together with BWAY and Central, the "Grantors"), with principal offices at 8607 Roberts Drive, Suite 250 Atlanta, GA 30350-2237, as follows:

**W I T N E S S E T H**

WHEREAS, the Grantors have heretofore granted to the Collateral Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications, including but not limited to those United States trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (the "Trademarks") to secure the Obligations (as defined in that certain U.S. Security Agreement, dated as of November 5, 2012, between the Collateral Agent, the Grantors, and the other guarantors party thereto (the "Security Agreement")), which security interests were recorded at the United States Patent and Trademark Office at Reel 4894, Frame 0011; and
