**TRADEMARK RELEASE**

TRADEMARK RELEASE, effective as of this 14 day of August, 2014, given by Deutsche Bank Trust Company Americas, as Collateral Agent, (the "Collateral Agent") with principal offices at 60 Wall Street, New York, New York 10005, to Ropak Corporation, a Delaware corporation (the "Grantor"), with principal offices at 8607 Roberts Drive, Suite 250, Atlanta, GA 30350-2237, as follows:

**W I T N E S S E T H**

WHEREAS, the Grantor has heretofore granted to the Collateral Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications, including but not limited to those United States trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (the "Trademarks") to secure the Obligations (as defined in that certain U.S. Security Agreement, dated as of November 5, 2012, between the Collateral Agent, the Grantor, and the other guarantors party thereto (the "Security Agreement")), which security interest was recorded at the United States Patent and Trademark Office at Reel 4947, Frame 0357; and

WHEREAS, the Collateral Agent wishes to release, assign, and restore all right, title and interest in and to the Trademarks to the Grantor and to dissolve any and all Liens and encumbrances respecting the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases, discharges, quitclaims and relinquishes unto the Grantor the continuing security interest in, and any other interest Collateral Agent may have in, such Grantor's right, title and interest in, to the Trademarks, whether then owned or thereafter acquired or arising wherever located, including but not limited to the Trademarks set forth on Schedule A granted to Collateral Agent by the Grantor pursuant to the Security Agreement.
