Pursuant to the provisions of §351.430 of The General and Business Corporation Law of Missouri, the undersigned corporations certify the following:

1. The constituent business corporations participating in the merger herein certified are:
 - (i) Coin Acceptors, Inc. ("MO-Coinco"), which is incorporated under the laws of the State of Missouri; and
 - (ii) Coin Acceptors, Inc. ("IA-Coinco"), which is incorporated under the laws of the State of Iowa.
2. A Plan of Merger has been approved, adopted, certified, executed, and acknowledged by each of the aforesaid constituent corporations by MO-Coinco in accordance with The General and Business Corporation Law of Missouri and by IA-Coinco in the same manner as is provided in the Iowa Business Corporation Act.
3. The name of the surviving corporation in the merger herein certified is IA-Coinco, which will continue its existence as said surviving corporation under its present name upon the effective date of said merger pursuant to the provisions of the Iowa Business Corporation Act.
4. The Certificate of Incorporation of IA-Coinco, as now in force and effect, shall continue to be the Certificate of Incorporation of said surviving corporation until amended and changed pursuant to the provisions of the Iowa Business Corporation Act.
5. The executed Plan of Merger between the aforesaid constituent corporations is on file at an office of the aforesaid IA-Coinco, the address of which is 300 Hunter Avenue, St. Louis, Missouri 63124.
6. A copy of the aforesaid Plan of Merger will be furnished by IA-Coinco, on request, and without cost, to any shareholder of any constituent corporation.
7. IA-Coinco agrees that it will promptly pay to the dissenting shareholders of MO-Coinco the amount, if any, to which they shall be entitled under provisions of Missouri law with respect to the rights of dissenting shareholders. It also agrees that it may be served with process in this state, and irrevocably appoints the Missouri Secretary of State as its agent to accept service of process in any proceeding based upon any cause of action against any such Missouri corporation arising in this state prior to the issuance of the certificate of merger, and in any proceeding for the enforcement of the rights of a dissenting shareholder of any such Missouri corporation against

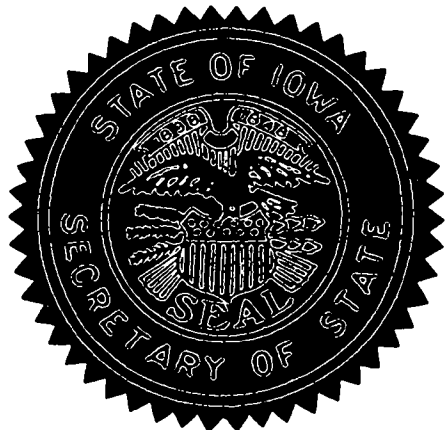

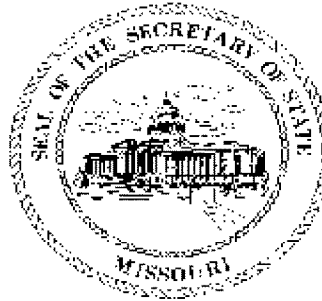

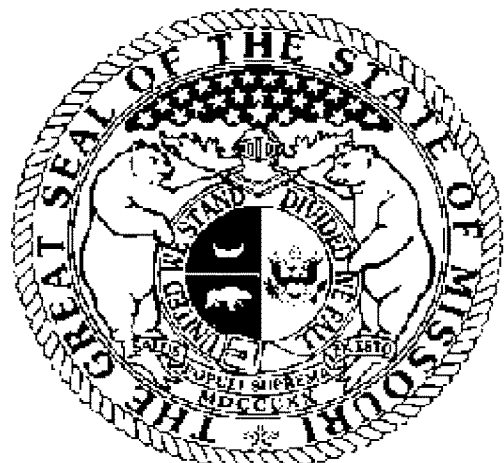
