**SECOND SUPPLEMENT TO GRANT OF  
SECURITY INTEREST IN UNITED STATES TRADEMARKS**

This Second Supplement to Grant of Security Interest in United States Trademarks (this "Second Supplement") is made as of the 15<sup>th</sup> day of August, 2014 by **SEQUENTIAL BRANDS GROUP, INC.**, a Delaware corporation, **HEELING SPORTS LIMITED**, a Texas limited partnership, **B@AND MATTER, LLC**, a Delaware limited liability company, **SEQUENTIAL LICENSING, INC.** (formerly known as Versatile Entertainment, Inc.), a California corporation, **WILLIAM RAST LICENSING, LLC**, a California limited liability company and **SBG REVO HOLDINGS, LLC**, a Delaware limited liability company (collectively, the "Existing Grantors"), and **GALAXY BRANDS LLC**, a Delaware limited liability company, **SBG UNIVERSE BRANDS, LLC**, a Delaware limited liability company, **SBG FM, LLC**, a Delaware limited liability company, **LNT BRANDS LLC**, a Delaware limited liability company, **THE BASKETBALL MARKETING COMPANY, INC.**, a Delaware corporation, and **AMERICAN SPORTING GOODS CORPORATION**, a Delaware corporation (collectively, the "New Grantors," and together with the Existing Grantors, the "Grantors"), in favor of **BANK OF AMERICA, N.A.**, as administrative agent and collateral agent (in such capacity, the "Grantee") for the credit parties under the Security Agreement (defined below).

**WHEREAS**, reference is made to that certain (a) Security Agreement dated as of March 28, 2013 (the "Existing Security Agreement"), entered into by, among others, the Existing Grantors and the Grantee, to which SBG Revo Holdings, LLC, joined as a party pursuant to the Joinder Agreement dated February 21, 2014 and (b) Grant of Security Interest in United States Trademarks dated March 28, 2013 and recorded with the United States Patent and Trademark office on March 28, 2013 at Reel 004993, Frame 0107 (the "Existing Grant"), executed and delivered by the Existing Grantors in favor of the Grantee, pursuant to which certain Existing Grantors pledged, assigned and granted a security interest in certain Marks (as defined therein), as supplemented pursuant to the First Supplement to Grant of Security Interest in United States Trademarks dated February 21, 2014 and recorded on March 18, 2014 at Reel 005239, Frame 0038 (the "TM Supplement," and together with the Existing Grant, collectively, the "Grant");

**WHEREAS**, the Grantors and the Grantee, among others, have agreed to amend and restate the Existing Security Agreement (as amended, restated, supplemented or otherwise modified and in effect from time to time, the "Security Agreement");

**WHEREAS**, pursuant to the Security Agreement, as further evidenced by the Grant, the Grantors have granted a security interest to the Grantee in, among other things, the Marks (as defined in the Existing Grant); and

**WHEREAS**, the Grantors have developed and/or acquired additional Marks and desire to hereby confirm the pledge of, and the grant of a security interest in, such additional Marks in favor of the Grantee.


**NOW, THEREFORE**, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
2. Supplement to Schedule A. Schedule A to the Grant is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto. For the purposes of clarity, from and after the date hereof, Schedule A shall be deemed to include (i) the Marks referenced on Schedule A as such Schedule A exists immediately prior to the date hereof (including as supplemented pursuant to the TM Supplement), and (ii) the Marks referenced on Schedule A-1 annexed hereto.
3. Miscellaneous:
  - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect. The Grantors hereby ratify, confirm and reaffirm all of the representations, warranties and covenants contained therein.
  - b. This Second Supplement and the Grant cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.


