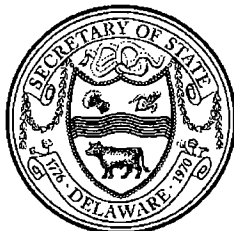

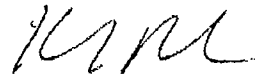

A LIMITED LIABILITY COMPANY

Pursuant to Title 8, Section 266 of the Delaware General Corporation Law and Title 6, Section 18-214 of the Delaware Limited Liability Company Act, Baseline Acquisitions Corp., a Delaware corporation (the "Corporation"), does hereby certify as follows relating to the conversion of the Corporation into a limited liability company:
