RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated August 7, 2014 (this "Release") is made by HSBC CORPORATE TRUSTEE COMPANY (UK) LIMITED, in its capacity as security agent for the Secured Parties referred to in the Security Agreement (as defined below) with a place of business at 8 Canada Square, London, E14 5HQ (the "Secured Party") of a Patent and Trademark Security Agreement dated February 6, 2013 and recorded on February 6, 2013 in the records of the United States Patent and Trademark Office (the "Security Agreement"), between the Secured Party and SURFCAM INC., a Delaware corporation ("Grantor").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, Grantor granted to the Secured Party, on behalf of itself and as Security Agent for certain other secured parties, a security interest in certain of Grantor's trademarks and trademark applications and registrations and, in particular, certain trademarks set forth on the attached Schedule A (the "Trademarks"); and

WHEREAS, the Secured Party wishes to: (i) release all of its security interest covering the Trademarks; (ii) restore all right, title, and interest in and to the Trademarks to Grantor; and (iii) dissolve any and all liens and encumbrances respecting the Trademarks

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trademarks, and discharges, quit claims and relinquishes unto Grantor (without recourse and without representation or warranty) any and all rights, title and interest it has in and to the Trademarks.
