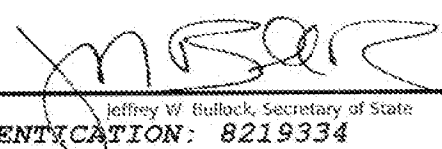

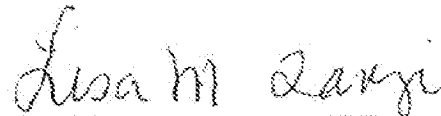
1. The name of the corporation (hereinafter called the "Corporation") is Hemisphere Broadcasting Corporation.
