RELEASE OF TRADEMARK SECURITY INTEREST

(Papernomad USA, LLC)

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the “Release”) is made effective as of August 18, 2014, by SUNTRUST BANK, as Administrative Agent (the “Administrative Agent”) to PAPER NOMAD USA, LLC (the “Grantor”) as follows:

WHEREAS, the Grantor, Griffin Technology, Inc., and the Administrative Agent are parties to that certain Third Amended and Restated Security Agreement dated as of December 17, 2013 (as may be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) executed in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to, and in connection with, the Security Agreement, the Grantor granted to the Administrative Agent on behalf of the holders of the Secured Obligations, among other collateral, a continuing security interest in all of the Grantor’s right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the “Marks”);

WHEREAS, in connection with, and in furtherance of, the granting of a security interest in the Marks, the Grantor executed and delivered to the Administrative that certain Trademark Security Agreement dated as of December 17, 2013 (as recorded on December 31, 2013 with the U.S. Patent & Trademark Office at reel 005193, frame 0421) for purposes of filing with the United States Patent and Trademark Office; and

WHEREAS, the Administrative Agent wishes to release its security interest in the Marks.

NOW THEREFORE, as the Grantor has satisfied its Secured Obligations under the various loan documents, the Administrative Agent hereby terminates, releases and discharges any security interest in and lien upon the Marks, and assigns, transfers, and conveys to the Grantor any and all right, title or interest in, or to, the Marks that the Administrative Agent may hold.
