TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (together with all Schedules hereto, this “**Trademark Assignment**”), dated as of July 18, 2014, is made and entered into by and between La Fe Foods, Inc., a Delaware corporation with its principal address located at 230 Moonachie Avenue Moonachie, NJ 07074 (“**Assignor**”), and Grace Foods Limited, a Saint Lucia limited company with its principal address located at 10 Manoel Street, P.O. Box 161, Castries, St. Lucia or its designees and assigns (collectively, “**Assignee**”). Capitalized terms used herein but not otherwise defined shall have the meanings set forth in the Asset Purchase Agreement, dated as of the date hereof, made and entered into among GraceKennedy Foods (USA) LLC, the Assignor, SW Property, L.L.C., Juan Carlos Pena, Juan Carlos Pena Trust Dated November 26, 1996, Francelia Margarita Pena and Francelia Margarita Pena Trust Dated November 26, 1996 (the “**Purchase Agreement**”).

WHEREAS, pursuant to the Purchase Agreement, the Assignor has agreed to sell, convey, transfer, assign and deliver to Assignee all right, title and interest, worldwide, in, to and under the Owned Intellectual Property, including the Assigned Trademarks (as defined below); and

WHEREAS, Assignor and Assignee desire to execute this Trademark Assignment for purposes of recording the assignment of the Assigned Trademarks and filing this Trademark Assignment with the United States Patent and Trademark Office and/or any other applicable intellectual property offices, entities and/or similar agencies outside of the United States of America, as may be necessary to effectuate the terms hereof.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained herein and for other good and valuable consideration, the parties hereto, intending to be legally bound hereby, agree as follows:

1. Assignment and Transfer. Assignor hereby sells, conveys, transfers, assigns and delivers to Assignee, its successors and assigns, and Assignee accepts, all of Assignor’s entire worldwide right, title and interest in, to and under (a) the Owned Intellectual Property, together with any and all goodwill connected with and/or symbolized by the Owned Intellectual Property, including the Trademarks and corresponding registrations and applications listed on Schedule A hereto together with any and all goodwill associated therewith (“**Assigned Trademarks**”) and (b) (i) all rights pertaining to the Owned Intellectual Property provided by or arising under international conventions and treaties, (ii) all rights and powers to assert, defend and recover title to Owned Intellectual Property; (iii) all rights to assert, defend, sue, and recover damages for any past, present and future infringement, misuse, misappropriation, impairment, unauthorized use or other violation of any rights in or to Owned Intellectual Property; (iv) all proceeds, income, royalties, damages and payments now and/or hereafter due and payable under and/or in respect of Owned Intellectual Property; and (v) all administrative rights arising from or pertaining to the Owned Intellectual Property, including the right to prosecute applications and oppose, interfere with or challenge the applications of others, the rights to obtain renewals, continuations, divisions, and extensions of legal protection pertaining to Owned Intellectual Property.

2. Terms of the Purchase Agreement. This Trademark Assignment is subject in all respects to the terms and provisions of the Purchase Agreement, including, but not limited to, Assignor's representations, warranties and covenants relating to the Owned Intellectual Property. Assignor acknowledges and agrees that the representations, warranties and covenants contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.


3. Miscellaneous. The provisions of Article IX of the Purchase Agreement shall apply to this Trademark Assignment, *mutatis mutandis*.
