AGREEMENT



4. Representations and Warranties of Assignee. Assignee hereby represents and warrants that once this Agreement is duly executed by both parties, it will constitute a legal, valid and binding agreement of the Assignee and is enforceable against it in accordance with its terms.
5. Binding Effect. This Agreement shall be binding upon and inure to the benefit of the parties, their successors and assigns.
6. Incorporation. To the extent applicable, the terms and provisions of the Purchase Agreement are incorporated herein by this reference.
7. Counterparts. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original by all of which together shall constitute one and the same instrument.
