RELEASE AND REASSIGNMENT OF  
TRADEMARKS AND TRADEMARK APPLICATIONS

Reference is hereby made to that certain Memorandum and Notice of Security Interest in Intellectual Property, dated as of August 31, 2007 (the "Agreement"), executed by Anna's Linens, Inc., a Delaware corporation (the "Corporation") in favor of Union Bank, N.A. NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Bank hereby: (i) terminates the Agreement; (ii) terminates, cancels, and releases any and all security interests it has against the Marks; and (iii) releases, retransfers and reassigns to the Corporation, without representation or warranty, all of the Bank's right, title and interest in and to the Marks and the goodwill associated therewith.
