UPON SAID CONSIDERATION, Assignor hereby agrees with the said Assignee that Assignor will not execute any writing or do any act whatsoever conflicting with this present, and that Assignor will, at any time upon request, without further or additional consideration but at the expense of said Assignee, execute such additional assignments and other writings and do such additional acts as said Assignee may deem necessary or desirable to perfect the Assignee's

enjoyment of this grant (including, without limitation, the recordation of the assignment), it being understood that these covenants and this assignment shall bind and inure to the benefit of the assigns and legal representatives of Assignor and Assignee; and

Assignor represents, warrants and covenants that neither Assignor nor any affiliate of Assignor shall, in the future, adopt or use, on its own behalf or under license or other grant, any trademark that shall be confusingly similar to the Trademarks, for any goods or services, in any territory worldwide.
