## ASSIGNMENT OF TRADEMARKS

Crawford has sold, assigned and transferred, and hereby does, sell, assign and transfer unto Centric the entire right, title and interest in and to the trademarks and registrations listed in Schedule A, together with the goodwill associated therewith, and the right to sue for, and recover for, any past infringements thereof, to be held and enjoyed by Centric, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Crawford had no sale and assignment of said Marks been made.


