**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "**Release**") is made as of August 19, 2014 ("**Effective Date**") by The Bank of New York Mellon, successor in interest to Mellon Bank, N.A. ("**BNY Mellon**"), as collateral agent (the "**Collateral Agent**") for the secured parties (as described in the Credit Agreement referred to below) in favor of Koppers Inc., a Pennsylvania corporation (formerly known as Koppers Industries, Inc., the "**Grantor**").

**WHEREAS**, reference is made to that certain Credit Agreement dated as of November 24, 1997 (as amended, amended and restated, supplemented, or otherwise modified from time to time, the "**Credit Agreement**") by and among the Grantor, the guarantors, banks, arrangers, and agents from time to time party thereto, and BNY Mellon as administrative agent and Collateral Agent; and

**WHEREAS**, in connection with the Credit Agreement, Grantor granted to Collateral Agent for the ratable benefit of the secured parties a security interest in, among other property, certain intellectual property of Grantor (collectively, the "**Collateral**"), including, without limitation, the United States trademarks, together with the goodwill associated therewith, set forth on Schedule A attached hereto; and

**WHEREAS**, a security interest in the Collateral was recorded with the United States Patent and Trademark Office on January 14, 1998 at, Reel/Frame 1672/0802; and

**WHEREAS**, Grantor was released from its obligations under the Credit Agreement on May 12, 2003;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby cancels and releases any and all security interests the Collateral Agent has against the Collateral listed on Schedule A.
