ARTICLES OF ORGANIZATION

This Amendment to the First Amended and Restated Articles of Organization ("Amendment") is made and entered into effective as of August 1, 2014, by INREIT Real Estate Investment Trust, a North Dakota Real Estate Investment Trust (the "Trust"), pursuant to Chapter 10-34 of the North Dakota Century Code (the "Act"):

**WHEREAS**, the Trust was formed under the Act pursuant to that certain Articles of Organization of the Trust, as filed in the Office of the Secretary of State of the State of North Dakota on December 4, 2002 (the "Articles");

**WHEREAS**, the Trust desires to amend the Articles to reflect the change of name of the Trust;

**NOW, THEREFORE**, the Articles are amended as follows:

1. Article I of the Articles is amended as follows:

**ARTICLE I**

The name of the Company is Sterling Real Estate Trust.

ARTICLES OF ORGANIZATION  
OF  
INREIT REAL ESTATE INVESTMENT TRUST

The undersigned organizer, being a natural person 18 years of age or older, in order to form a real estate investment trust company under North Dakota Century Code, Chapter 10-34, hereby adopts the following Articles of Organization.

ARTICLE I

The name of this Company is Inreit Real Estate Investment Trust.

ARTICLE II

The purpose for which the Company is organized is to qualify as a real estate investment trust under Code Section 856 of the Internal Revenue Code and operate as such.

ARTICLE III

The date of formation of the company is November 1, 2002. The State of formation is North Dakota.

ARTICLE IV

The Company's period of duration is perpetual.

ARTICLE V

The principal executive office and the registered office of this Company is located at 216 South Broadway, Suite 202, Minot, ND 58701. The registered agent at that address is Randy I. Westby. The Secretary of State is appointed if the registered agent's authority has been revoked or if the agent cannot be found or served with the exercise of reasonable diligence.

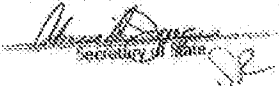

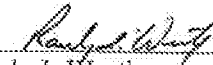
