

Pursuant to Section 251(c) of the General Corporation Law of the State of Delaware, as amended (the "DGCL"), USA Mobility Wireless, Inc., a Delaware corporation (the "Corporation"), hereby certifies the following information relating to the merger of Amcom Software, Inc., a Delaware corporation, with and into the Corporation (the "Merger"):

FIRST: The name and state of incorporation of each of the constituent corporations to the Merger (the "Constituent Corporations") are as follows:

FOURTH: Upon the effectiveness of the Merger in accordance with Section 251 of the DGCL and Section 103 of the DGCL (the "Effective Time"), the certificate of incorporation of the Corporation, as in effect immediately prior to the Effective Time, shall continue to be the Certificate of Incorporation of the Surviving Corporation until further amended pursuant to the DGCL.


