

2. The directors of the Corporation approved the foregoing amendment by unanimous written consent, pursuant to Section 141(f) of the DGCL; and


3. The sole stockholder of the Corporation approved the foregoing amendment via written consent, pursuant to Section 228(a) of the DGCL.
