THIS GRANT OF SECURITY INTEREST, dated as of April , 2014, is executed by Vidsys, Inc., a Delaware corporation with an address of 8219 Leesburg Pike, Ste. 250, Vienna, VA 22182 ("Debtor"), in favor of HORIZON FUNDING TRUST 2013-1, a trust created and existing pursuant to the laws of the State of Delaware, with an address of 312 Farmington Avenue, Farmington, Connecticut 06032 ("Secured Party").

Debtor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Collateral granted hereby are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
