RELEASE OF TRADEMARK SECURITY AGREEMENT

This RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), dated as of August 19, 2014, by CREDIT SUISSE AG, a Swiss bank located at Eleven Madison Avenue, New York, New York 10010 ("Releasor"), in favor of Safe-Guard Products International, LLC, located at Two Concourse Pkwy, Suite 500, Atlanta, GA 30328 ("Releasee").

W I T N E S S E T H:

WHEREAS, Releasee and Releasor entered into that certain First Lien Security Agreement, dated as of December 21, 2012 (as from time to time amended, modified, supplemented or restated, together with all exhibits and schedules thereto, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the parties entered into that certain First Lien Trademark Security Agreement, dated as of December 21, 2012, which is recorded in the United States Patent and Trademark Office (the "Recorded Security Agreement"), under which Releasee granted to Releasor, a security interest in all of such Releasee's right, title and interest in such Releasee's Trademarks (including the Trademarks set forth on Schedule A), together with all Proceeds (such as license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements rights throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof and Goodwill associated therewith (as applicable) (collectively, the "Trademark Collateral"); and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Trademark Security Agreement to terminate, release, relinquish and discharge any and all of its security interest in the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule A attached hereto.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Recorded Security Agreement.

2. Release of Security Interest. The Releasor hereby, without any representation and warranty, terminates, releases, relinquishes and discharges any and all interests it may have in the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule A attached hereto.
