This Assignment is made to assign the Marks to Assignee and to perfect and confirm any prior assignments thereof to Assignee, and to permit the same to be recorded.

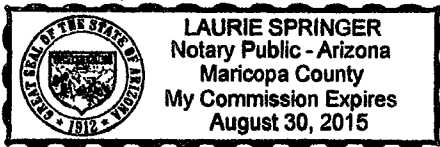
