Assignment

This Assignment of Trademark ("Assignment"), effective as of June 2, 2014, is made by and between Rock Bottom Restaurants, Inc., a Delaware corporation ("Rock Bottom"); and Rockies Trademark, LLC, a Colorado limited liability company, ("RTI"). Rock Bottom and Rockies shall be referred to collectively as "the Parties."

Recitals

Rock Bottom owns a US Trademark Reg. No. 3,076,169 for SUNDANCE for "beer" and all common law rights associated therewith and all goodwill identified thereby (collectively the "SUNDANCE Registration");

Rock Bottom wishes to assign the SUNDANCE Registration to RTI to enable RTI to immediately assign it to Boulder Beer, Inc., a Colorado corporation ("BBI"), as part of the June 2, 2014 Asset Transfer and Distribution Agreement by and between CraftWorks Restaurant & Breweries Group, Inc., RB Capital, Inc., Rock Bottom Restaurants, Inc., Rockies Trademark, LLC, Boulder Beer, Inc. ("BBI"), 2880 Wilderness, Inc.; and Gina Day.

Agreement

In consideration of the promises herein contained, the receipt and sufficiency of which the parties acknowledge, the Parties agree as follows:

1. Rock Bottom hereby assigns to RTI, for subsequent assignment to BBI, any and all rights, title and interest it may have in and to the SUNDANCE Registration, and all claims for damages by reason of past, present or future infringement, dilution or misappropriation of the foregoing, with the right to sue for and collect the same.
2. Rock Bottom hereby assigns to RTI, for subsequent assignment to BBI, and RTI hereby assumes and accepts, all liability for that Trademark Agreement by and between Sundance Enterprises, Inc. and RBR executed in November of 2009.
3. This Assignment may be executed in multiple counterparts and by facsimile or electronic signature, any one of which will be deemed an original, but all of which shall

constitute one and the same instrument.
