**GRANT OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

This GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (“Agreement”), effective as of August 7, 2014 is made by UHS OF DELAWARE, INC., a Delaware corporation located at 367 South Gulph Road, King of Prussia, Pennsylvania 19406 (the “Obligor”), in favor of JPMORGAN CHASE BANK, N.A., a national banking association located at 10 S. Dearborn, 7th Floor, Chicago, IL 60603 as Collateral Agent (the “Collateral Agent”) for the Secured Parties.

**W I T N E S S E T H:**

WHEREAS, pursuant to the Credit Agreement dated as of November 15, 2010 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), among Universal Health Services, Inc., a Delaware Corporation (“Borrower”), the several banks and other financial institutions (the “Lenders”) parties thereto, the Administrative Agent and the other agents named therein, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, in connection with the Credit Agreement, the Borrower and the Obligor have executed and delivered a Collateral Agreement, dated as of August 7, 2014 in favor of the Collateral Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement, the Obligor and Borrower pledged and granted to the Collateral Agent for the benefit of the Collateral Agent, for the ratable benefit of the Secured Parties, a continuing security interest in all Intellectual Property, including the Trademarks; and

WHEREAS, the Obligor and Borrower have duly authorized the execution, delivery and performance of this Agreement;




