1. I am Comptroller of General Tools & Instruments Company LLC, a limited liability company organized under the laws of the State of New York, and am authorized to act on behalf of, and render this Declaration for, General Tools & Instruments Company LLC.

2. U.S. Trademark Registration No. 2,051,768, issued April 15, 1997, for the trademark "MANNIX" for goods recited in International Classes 9 and 14, was transferred via an Assignment recorded in the United States Patent and Trademark Office on October 26, 2006, from Mannix Testing and Measurement Corp. to General Tools Mfg. Co., LLC, along with the associated goodwill; the Assignment executed September 28, 2006, and being recorded at Reel No. 3416, Frame No. 0663.

3. Subsequent to the recordation of the Assignment from Mannix Testing and Measurement Corp. to General Tools Mfg. Co., LLC recorded on October 26, 2006, "General Tools Mfg. Co., LLC" changed its name, and transferred the entirety of its business interests, to "General Tools & Instruments Company LLC," the current entity doing business under the "MANNIX" trademark for the goods recited in U.S. Trademark Registration No. 2,051,768, and located, at 80 White Street, New York, New York 10013.
