**ARTICLES AND CERTIFICATE OF CONVERSION
CONVERTING

Pursuant to the provisions of Section 2.15 of the Texas Revised Limited Partnership Act and Section 17-217 of the Delaware Revised Uniform Limited Partnership Act, Power Well Services, L.P., a Texas limited partnership (the "Converting Entity"), hereby executes the following Articles and Certificate of Conversion:

An executed copy of the Plan will be provided, on written request and without cost, to any partner of the Converting Entity or any partner of the Converted Entity, by the Converting Entity, if such request is made prior to the conversion becoming effective, or by the Converted Entity, if such request is made after the conversion becomes effective.
5. The approval of the Plan was duly authorized by all action required under the Texas Revised Limited Partnership Act and the Converting Entity's constituent documents.
