**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of August 28, 2014, is made by General Electric Capital Corporation, as administrative agent ("Agent"), in favor of Rhinelander Coated Products, LLC, a Delaware limited liability company ("Grantor") as follows:

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Agent; and

WHEREAS, the Grantor has requested that the Agent release its Lien on and security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases the Lien on and security interest in the Trademark Collateral and any and right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.


The Agent agrees to provide Grantor with any information and additional authorization and documentation necessary to effect the release of the Agent's security interest in the Trademark Collateral (without recourse, representation or warranty and at Grantor's sole cost and expense).
