## ASSIGNMENT OF PATENTS AND TRADEMARKS

This Assignment of Patents and Trademarks is made on August 15, 2014 between:

- (1) **HOSPIRA, INC.**, a company incorporated in the State of Delaware, United States of America, with offices at 275 North Field Drive, Lake Forest, IL 60045 (“HOSPIRA”); and
- (2) **AMSINO MEDICAL GROUP HOLDINGS CO., LTD.**, a company formed under the laws of the Cayman Islands (“AMSINO”).

### WHEREAS:

- (A) HOSPIRA is the owner of the Hospira Patents and the Hospira Trademarks, as those terms are defined herein;
- (B) HOSPIRA and AMSINO wish to enter into this Assignment in order to assign the Hospira Patents and the Hospira Trademarks from HOSPIRA to AMSINO; and
- (C) HOSPIRA and AMSINO wish to confirm their agreement as to said assignment of the Hospira Patents and the Hospira Trademarks on the terms and conditions set forth herein.

### HOSPIRA and AMSINO hereby agree as follows:

1. In this Assignment of Patents and Trademarks, the following words and expressions shall have the following meanings:
  - (A) “Hospira Patents” means the patents listed in Schedule A to this Assignment;
  - (B) “Hospira Trademarks” means the trademarks listed in Schedule B to this Agreement.
2. For good and valuable consideration, the receipt and sufficiency of which is acknowledged by HOSPIRA, HOSPIRA hereby assigns to AMSINO all of Hospira’s right, title, and interest in and to the Hospira Patents and the Hospira Trademarks, including: (i) all goodwill associated with the Hospira Trademarks; and (ii) all rights of action, powers, and benefits belonging or accrued to the same, including the right to take action and collect damages with respect to infringements occurring prior to the date hereof.

3. HOSPIRA will, at AMSINO's reasonable request, execute all documents that are reasonably necessary for giving full effect to the terms and provisions of this Assignment of Patents and Trademarks, including documents that are necessary for AMSINO to be recorded as the owner of the Hospira Patents and the Hospira Trademarks. Amsino shall be solely responsible for and shall bear the registration or other official fees relating to the recordation of this Assignment of Patents and Trademarks.
4. This Assignment shall be governed by and construed in accordance with the laws of the State of Illinois, United States of America.


