**RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES
TRADEMARKS**

This Release of Grant of Security Interest in United States Trademarks (this “Release”) is made as of August 29, 2014, by Crystal Financial LLC, a Delaware limited liability company with an office at Two International Place, 17th Floor, Boston, Massachusetts 02110, in its capacity as Agent under (and as defined in) the Security Agreement referred to below (the “Secured Party”) for the benefit of Active Media Services, Inc., a Delaware corporation, located at One Blue Hill Plaza, Pearl River, New York, 10965 (the “Debtor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

W I T N E S S E T H:

WHEREAS, the Debtor and the Secured Party are parties to that certain Grant of Security Interest in United States Trademarks dated as of July 1, 2013 (as amended, restated or otherwise modified through the date hereof, the “Security Agreement”), pursuant to which the Debtor has granted to the Secured Party for its benefit and the benefit of various other financial institutions, a security interest in the trademarks set forth on Schedule A hereto (the “Trademarks”) and the goodwill of the business symbolized by such Trademarks, and the registrations and applications therefor (together with the Trademarks, the “Trademark Collateral”);

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office at Reel 5065 and Frame 0396 on July 8, 2013; and


WHEREAS, the Debtor has requested that the Secured Party provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release of its security interest, and claims of security interest, in the Trademark Collateral and the Secured Party is willing to provide such document, subject to the terms hereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. The Secured Party does hereby terminate, release and discharge the entirety of any and all security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement to the Trademark Collateral and any right, title or interest of the Secured Party in such Trademark Collateral shall hereby terminate, cease and become void. The Secured Party hereby assigns, transfers and conveys any and all right, title or interest of the Secured Party in the Trademark Collateral to the Debtor.
2. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, the undersigned has caused this Release of Grant of Security Interest in United States Trademarks to be executed and delivered as of the date first written above.

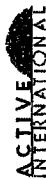
