RELEASE OF SECURITY INTEREST

Recital

Lender shall take all further actions, and provide to the Company, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Company, and at Company's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
