

The corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

1. That the name of the corporation is Cigars International, Inc. (the "Corporation").

2. That the Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on June 30, 2004.

3.
