TRADEMARK RELEASE OF SECURITY INTEREST

THIS TRADEMARK RELEASE OF SECURITY INTEREST (this “Release”) is made as of August 29, 2014, by GENERAL ELECTRIC CAPITAL CORPORATION, in its capacity as administrative agent (“Agent”).

WITNESSETH:

Agent hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Agent, all of Agent’s right, title and interest in, to and under the Trademark Collateral, and the goodwill of Grantor’s business connected with the use of and symbolized by the Trademark Collateral.
