**NOTICE OF RELEASE, RELINQUISHMENT & DISCHARGE  
OF SECURITY INTEREST**

WHEREAS W.J. Dennis & Company, having its principal place of business located at 1111 Davis Road, Elgin, Illinois, 60123, United States of America ("W.J. Dennis"), through a predecessor in title, namely, RCR Acquisition Corp. B/K/A W.J. Dennis & Company, had entered into a Security Agreement dated April 4, 1996 (the "Security Agreement") with National Bank of Canada ("Creditor"), whereby W.J. Dennis granted to Creditor a secured interest in certain property, including United States trademark registration number 1,219,971 for CAULKSAV'R (the "Trademark"), in consideration of the provision of certain credit facilities to W.J. Dennis;

AND WHEREAS on or around May 3, 1996, the Security Agreement was registered against the Trademark at the United States Patent and Trademark Office;

AND WHEREAS Creditor has agreed to release W.J. Dennis from the Security Agreement and all underlying and related security interest obligations and to discharge the Security Agreement granted by W.J. Dennis for such obligations including with respect to the Trademark.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Creditor, Creditor agrees as follows:

1. Creditor hereby relinquishes, releases and terminates all of its right, title and interest in and to the Trademark.
2. Creditor hereby directs the United States Patent and Trademark Office to record the present Notice of Release, Relinquishment & Discharge of Security Interest (the "Release") against the Trademark and in such places as it deems necessary or advisable to give effect hereto.
3. The present Release is executed in accordance with and is subject to, governed by and interpreted in accordance with the applicable Canadian laws.




