## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

The Lender hereby agrees, at the Borrower's expense, to take such further actions and to execute and deliver such further documents as the Borrower may reasonably request to effect and evidence this Release, including, without limitation, the execution and delivery of any filings, statements, amendments, recordations or other instruments required to effect this Release and the recordal of same. The Borrower agrees to pay the Lender for all reasonable out-of-pocket costs and expenses incurred by the Lender in connection with the matters referred to in this paragraph (including the legal fees of its counsel) upon receipt of documented evidence of such expenses.
