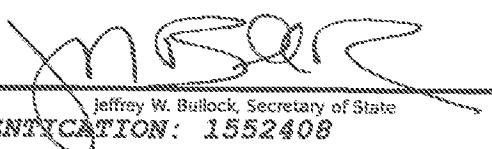

Third: The Agreement of Merger has been approved and executed by both the corporation and limited liability company.

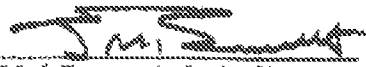
Fourth: The name of the surviving limited liability company is One Three Television, LLC.
