## RELEASE OF SECURITY INTEREST

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, UniCredit S.p.A. – New York Branch (f/k/a UniCredito Italiano, New York Branch) (the “Bank”), whose address is 150 E 42<sup>nd</sup> St., New York, New York 10017, pursuant to that certain Letter Agreement dated as of December 27, 2000 among the Bank and Brooks Brothers Group, Inc., a Delaware corporation (f/k/a Retail Brand Alliance, Inc.) (the “Borrower”) (as the same may have been amended, amended and restated, supplemented or otherwise modified from time to time, the “UniCredit Loan Agreement”), does hereby unconditionally and expressly release, terminate and forever discharge any and all of its right, title and interest in and to any and all liens on and security interests in all intellectual property collateral identified in the Amended and Restated Security Agreement dated as of March 28, 2003, among the Bank, Borrower and Brooks Brothers, Inc., a Delaware corporation (as the same may have been amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), including the trademarks listed on Exhibit A attached hereto, (the “Released Collateral”), which was recorded in the United States Patent and Trademark Office (“PTO”) on or about May 9, 2003, against the United States trademarks listed on Exhibit A at Reel/Frame Numbers 2724/0417. The Bank hereby releases, retransfers and reassigns to the Borrower the security interest and all of the Bank’s right, title and interest in, to and under the Released Collateral. The Bank will execute and deliver, at the request and cost of Borrower, such further instruments, documents and release forms as Borrower may reasonably request to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.

This Release of Security Interest shall be binding upon the Bank’s legal representatives, assigns and successors. The Bank hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release of Security Interest.
