**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS Flint Ink Corporation, a Michigan corporation with an address at 4600 Arrowhead Drive, Ann Arbor, MI 48105 (the "Grantor"), entered into that certain security agreement dated January 11, 2006, (the "Security Agreement") with J.P. Morgan Europe Limited, as security agent and trustee (the "Security Agent"), notice of which was recorded at the United States Patent and Trademark Office at Reel 3234, Frame 0905.

WHEREAS, Grantor granted the Security Agent, under the terms of the Security Agreement, a continuing security interest (the "Security Interest") in favor of the Security Agent, in and to certain of Grantor's intellectual property, including the trademarks listed in Schedule A (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, the Security Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Security Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges all liens and the Security Interest, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantor and its successors and assigns in association with the Security Interest, and hereby releases Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
