ASSIGNMENT OF TRADEMARK

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby assign and transfer to ASSIGNEE, its successors and assigns, ASSIGNOR’S entire right, title and interest in and to the Trademark Rights, including, without limitation, the right to sue for, assert claims or demands, settle and/or release, and recover damages and all other remedies for any past or present or future infringements thereof, the same to be held and enjoyed by ASSIGNEE, its successors and assigns to the same extent that such right, title and interest, if any, would have been held and enjoyed by ASSIGNOR if this Assignment had not been made.

Subject to the terms and conditions of the APA, ASSIGNOR agrees to execute all such other documents as may be reasonably needed to establish ASSIGNEE as the record owner of the Marks.

In the event of a conflict between the terms and conditions of this Trademark Assignment and the terms and conditions of the APA, the terms and conditions of the APA shall govern and control.
