

No Additional Warranties.** The Federal Trademark is sold and assigned to Buyer without any warranty of title, non-infringement, merchantability, or fitness for a particular purpose except as specifically provided in that certain Asset and Real Property Purchase Agreement (the "Purchase Agreement") by and between Buyer and Seller, dated December 31, 2013.

**4. Maintenance; Compliance.** Buyer shall be responsible for making all necessary or appropriate filings with the USPTO (i) to document or evince Buyer's ownership of the Federal Trademark, and (ii) to maintain all federal registrations for the Federal Trademark.
