**CONFIRMATORY DEED OF ASSIGNMENT
(North America)**

THIS DEED made the 28th day of August 2014

BETWEEN

CSL Limited of 45 Poplar Road, Parkville Victoria 3052, Australia ("the Assignor") of the one part

AND

CSL Behring Recombinant Facility AG of Wankdorfstrasse 10, 3000 Bern 22, Switzerland ("the Assignee") of the other part

WHEREAS

- A. The Assignor is the registered owner or Applicant for registration in various countries for the trade marks listed in Schedule A ("the said trade marks").
- B. In the United States of America, the Assignor intends to use those trade marks listed in Schedule A in the United States of America and has filed those listed applications in the United States of America indicating that intention but has not yet filed Statements or Allegations of Use under Section 1(c) or 1(d) of the United States Trademark Act.
- C. The Assignor is assigning the trade marks in the United States of America applications in Schedule A as part of the entire ongoing and existing business to which those trade marks pertain.
- D. Pursuant to a Licence Agreement dated 27 June 2014, the Assignor transferred ownership of all right, title and interest of the Assignor in and to the said trade marks to the Assignee.

NOW THIS DEED WITNESSETH

- 1. That for good and valuable consideration detailed in the Licence Agreement, the sufficiency and receipt of which the Assignor hereby acknowledges, the Assignor assigned transferred and set over unto the Assignee all the right title and interest


of the Assignor in and to the said trade marks and their respective applications as set forth in Schedule A, together with all goodwill associated with the said trade marks and that portion of the ongoing and existing business to which the said trade marks pertain, together with the right to recover damages for any and all past infringements thereof, as well as any and all rights under any causes of action having accrued heretofore with respect to the said trade marks in the United States of America, its territories, Canada, and in any and all other countries, to hold unto the Assignee absolutely. The assignment being effective from 30 June 2014.

- 2. This Deed may be executed in any number of counterparts, and by the parties on separate counterparts. Each counterpart shall constitute an original of this Agreement, but all the counterparts shall together, constitute one and the same Agreement.
