TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is entered into *nunc pro tunc*, effective as of January 5, 2010 ("Effective Date"), between The RLJ Companies, LLC and Axiom Bancshares, Inc., with each referred to as a "Party" and collectively "the Parties."

WHEREAS, The RLJ Companies, LLC previously sold and transferred some time ago the Urban Trust Bank business and all of its interest in Urban Trust Holdings Inc., including the Trademark, to Urban Trust Holdings, Inc. and, the Parties now desire to clean up the chain of title and records respecting that previous sale and transfer of the Urban Trust Bank business, including the chain of title to the Trademark, with this Trademark Assignment;

WHEREAS, The RLJ Companies, LLC, a limited liability company organized under the laws of the State of Delaware, having a principal place of business at 3 Bethesda Metro Center, Suite 1000 Bethesda, Maryland, 20814 ("Assignor"), is the owner of all right, title, and interest in and to the trademark URBAN TRUST BANK, including the goodwill of the business symbolized thereby, and the following corresponding U.S. Registration for such mark listed immediately below ("the Trademark");

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby quitclaims, assigns and transfers as of the Effective Date to Assignee, the entire worldwide right, title and interest in and to the Trademark, together with the goodwill of the business symbolized thereby, and including but not limited to, any and all trademark applications or registrations for the Trademark, including the U.S. registration listed above, any copyright rights in and to the Trademark or its associated designs, the right to sue for and recover past damages and other remedies in respect of any infringement of the Trademark which may have occurred prior to the Effective Date of this Assignment, and the right to prosecute applications and maintain and renew registrations for the Trademark.
